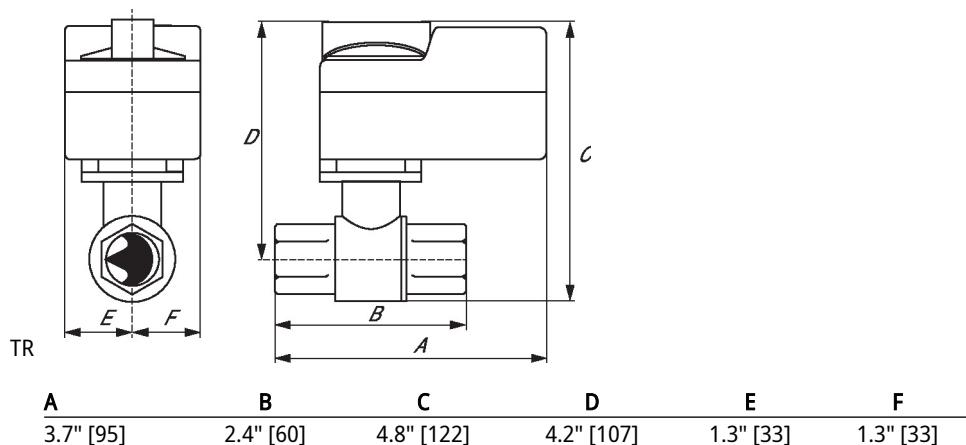

Flow/Mounting details


