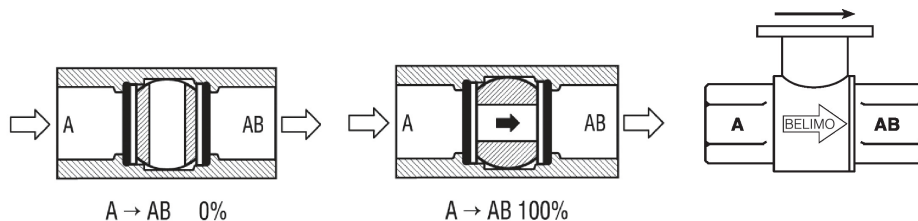

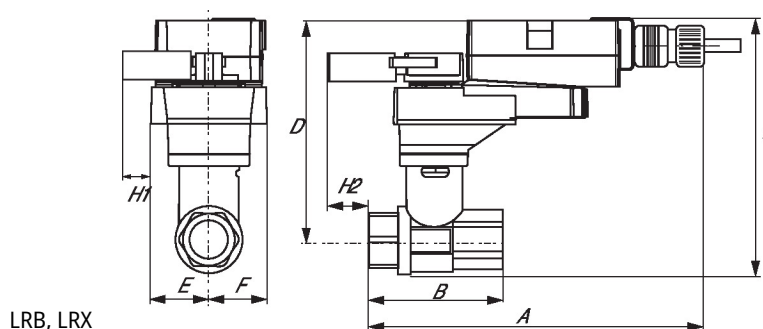
Flow/Mounting details

Two-way valves should be installed with the disc upstream.



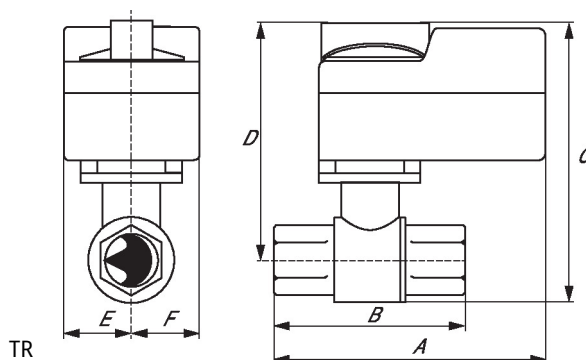

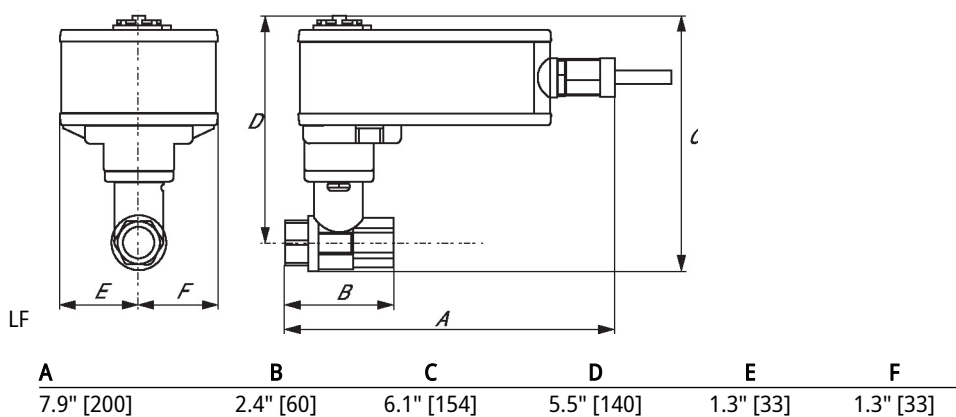
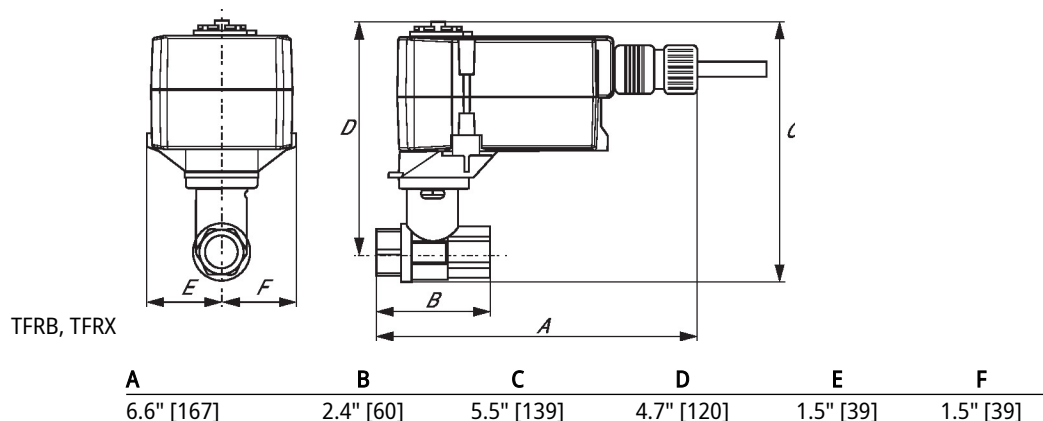

- 1 Provide overload protection and disconnect as required.
- 2 Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- 3 Actuators may also be powered by DC 24 V.
- 44 One built-in auxiliary switch (1x SPDT), for end position indication, interlock control, fan startup, etc.
