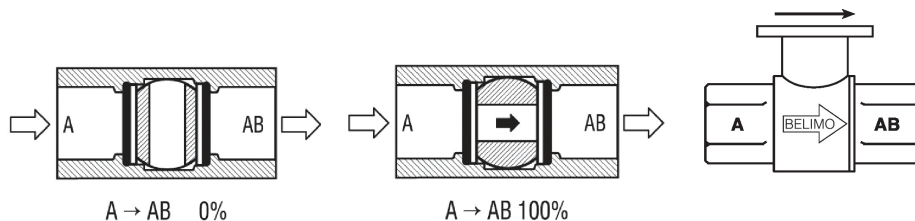
## Product features

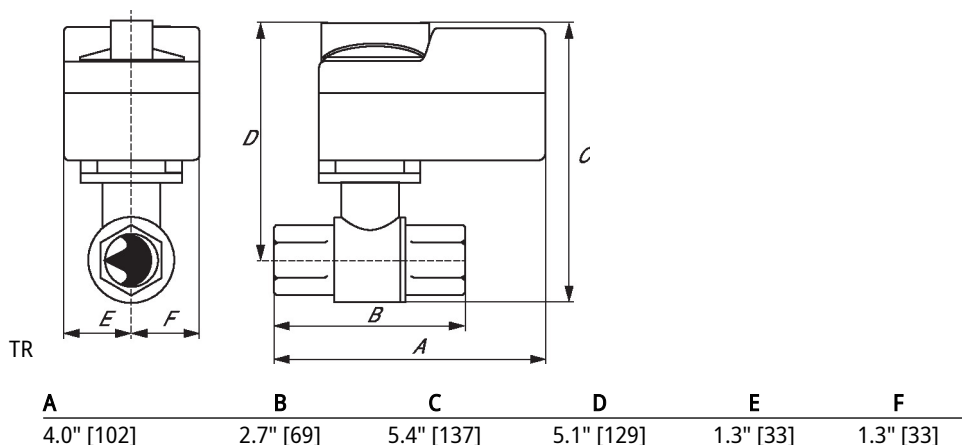
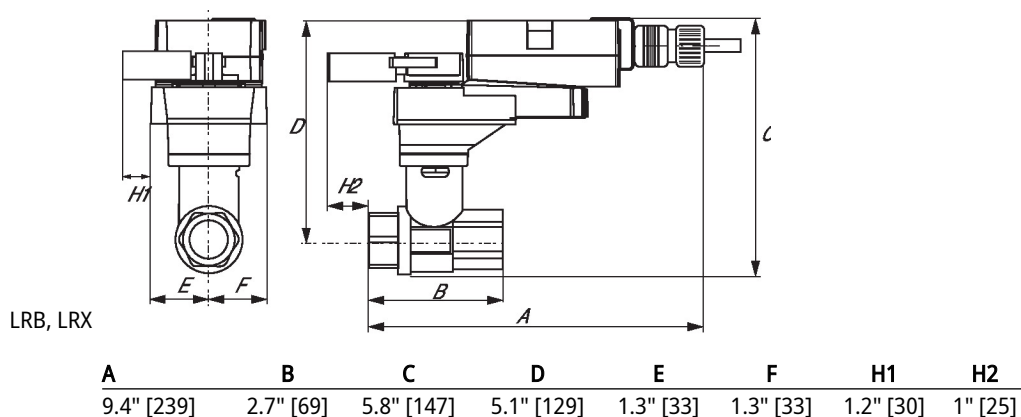
### Flow/Mounting details

- 18 Actuators with plenum cable do not have numbers; use color codes instead.
