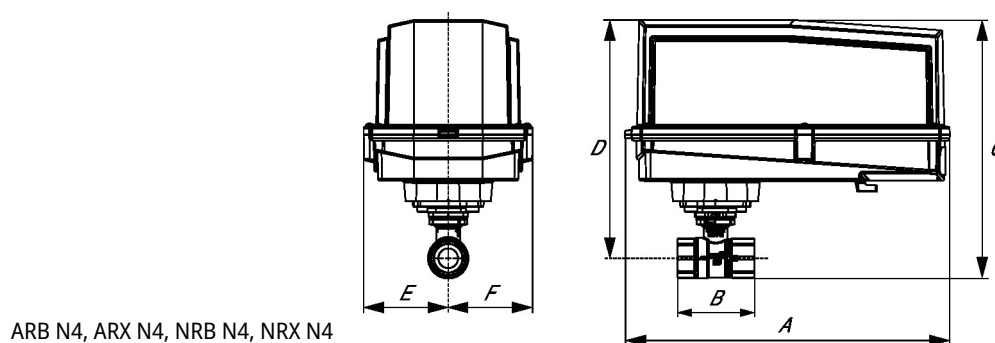
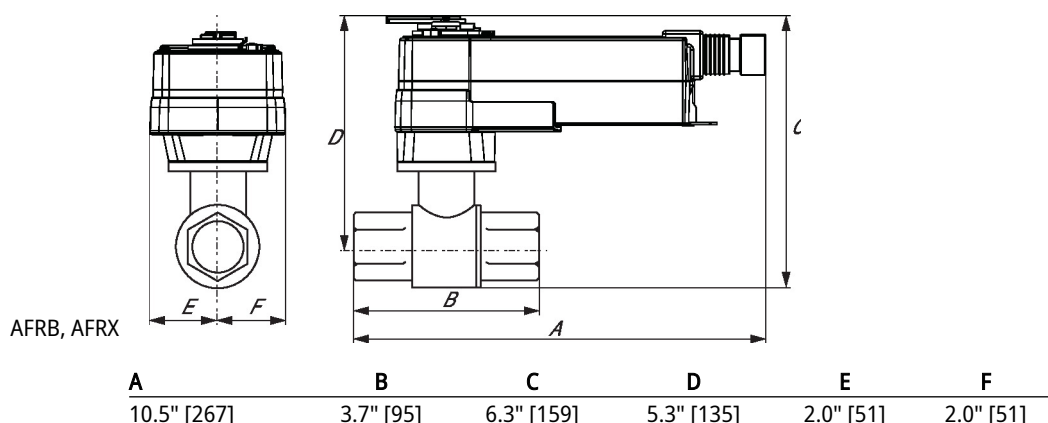
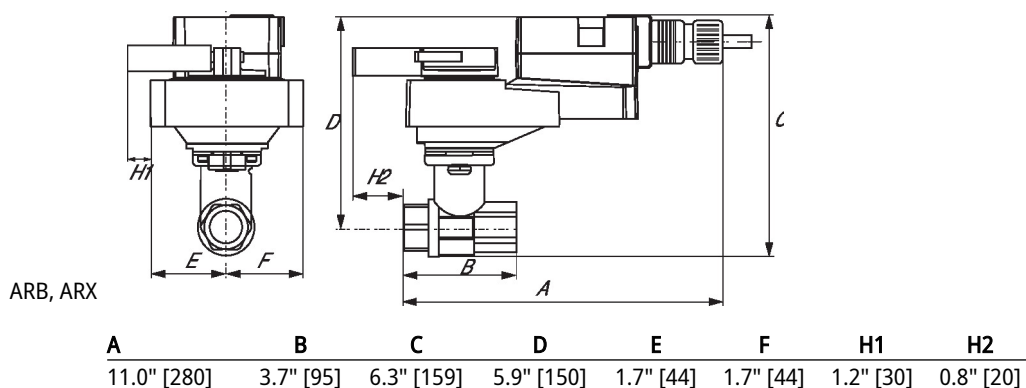
Flow/Mounting details

Two-way valves should be installed with the disc upstream.



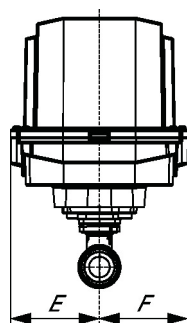
