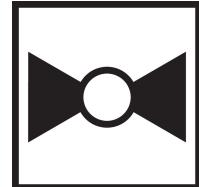

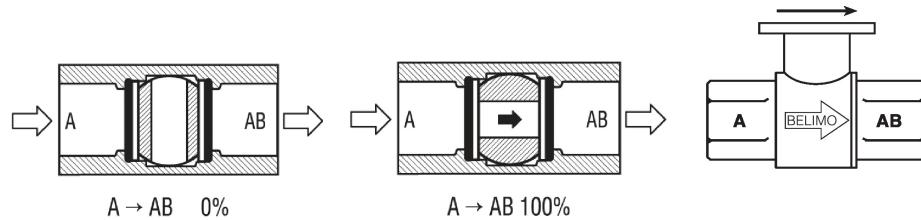
Product features

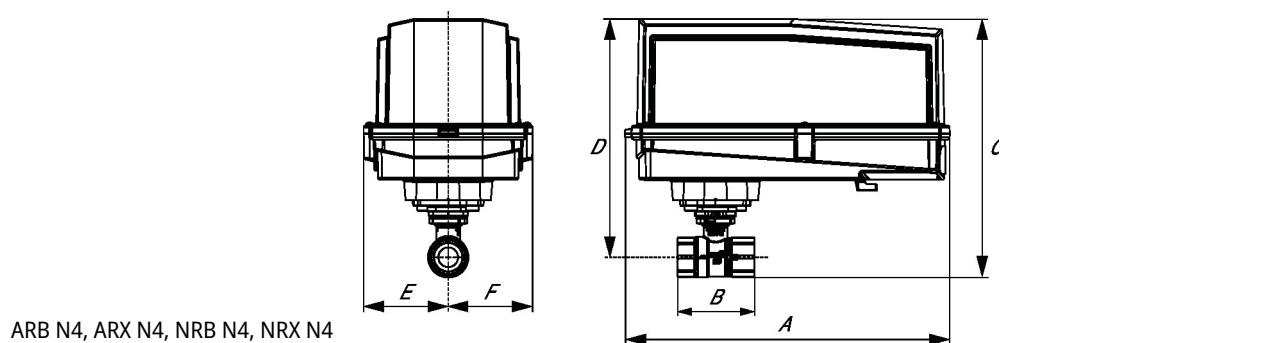
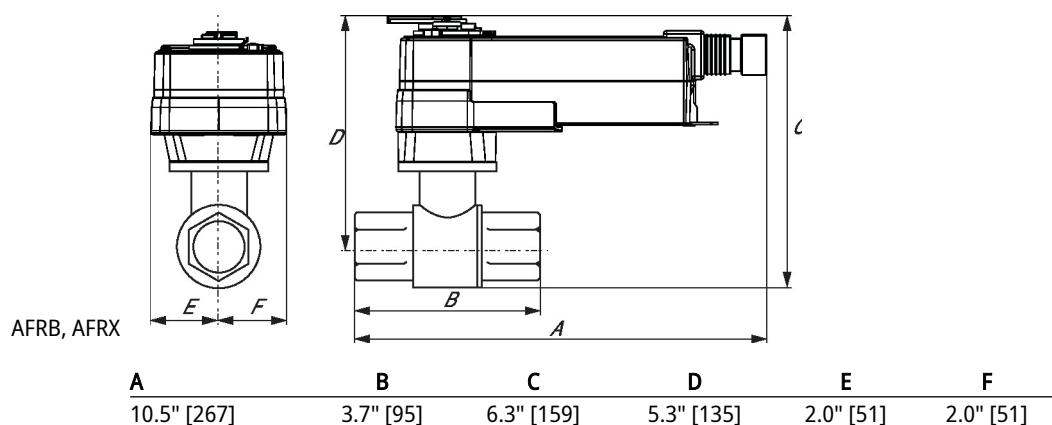
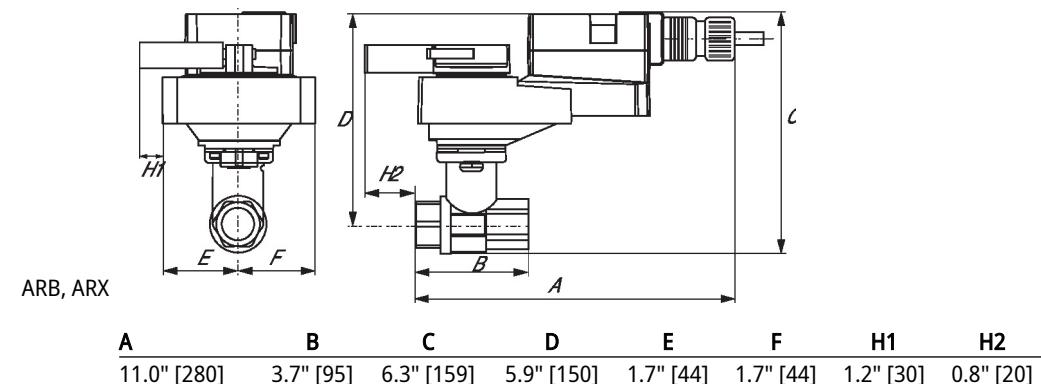
Flow/Mounting details

Two-way valves should be installed with the disc upstream.



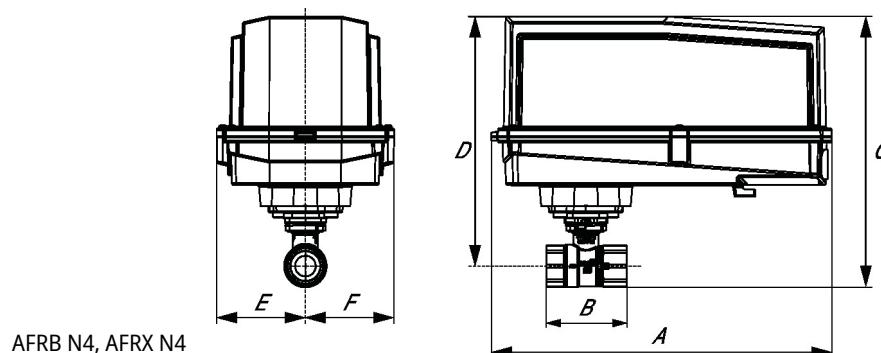

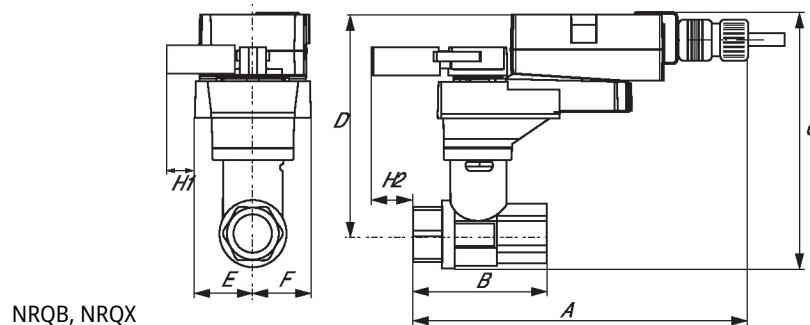

- Ⓐ Actuators with appliance cables are numbered.
- △1 Provide overload protection and disconnect as required.
- △2 Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- △5 Only connect common to negative (-) leg of control circuits.
- △7 A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- ◆ Meets cULus requirements without the need of an electrical ground connection.
