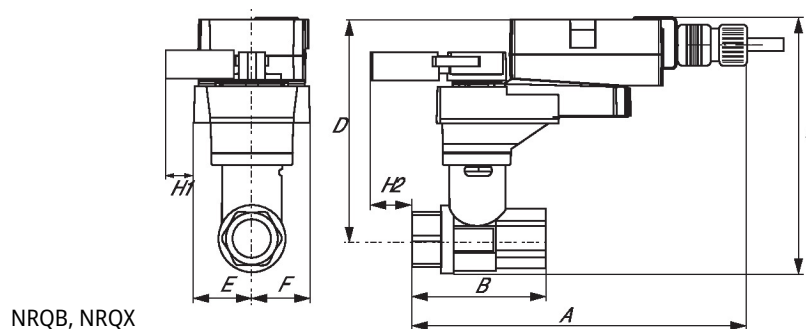
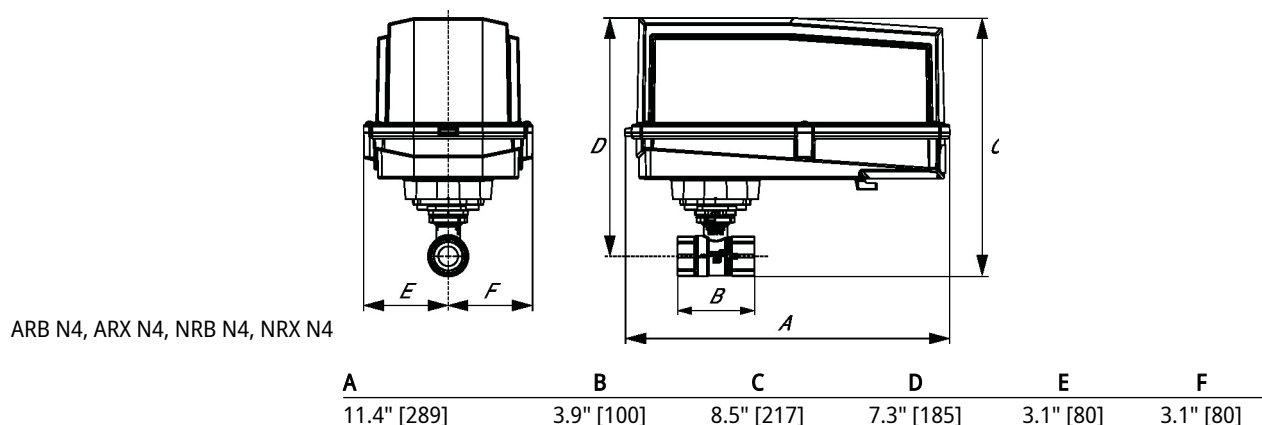
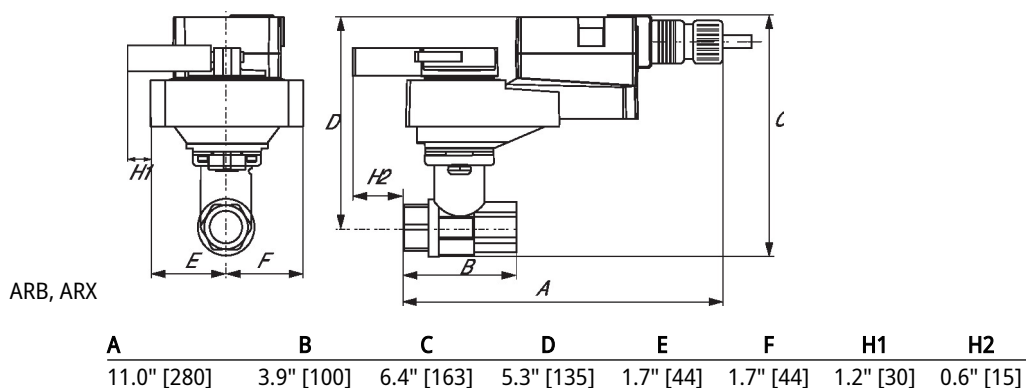
## Flow/Mounting details
