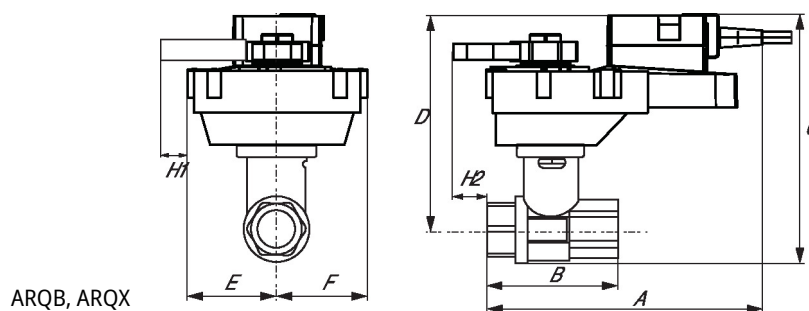
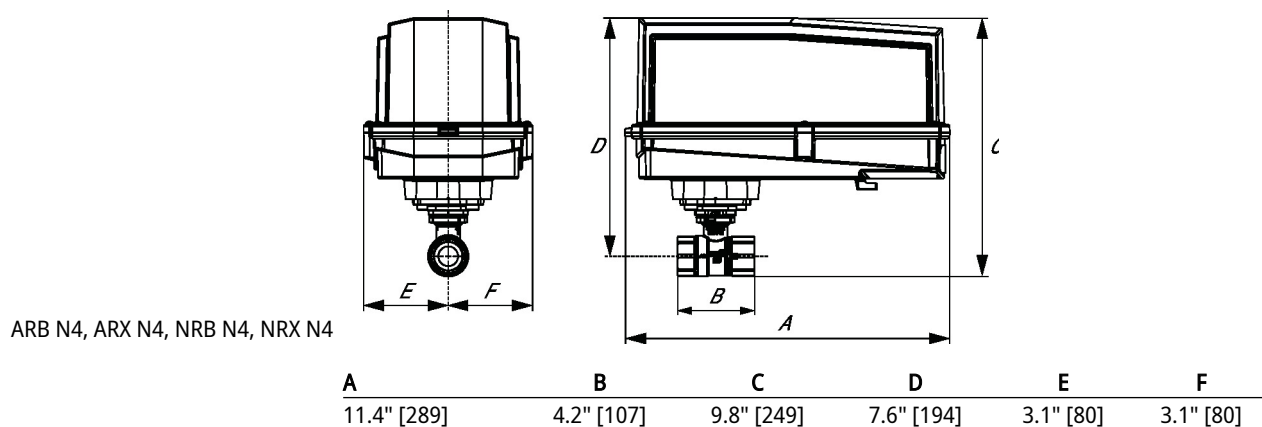
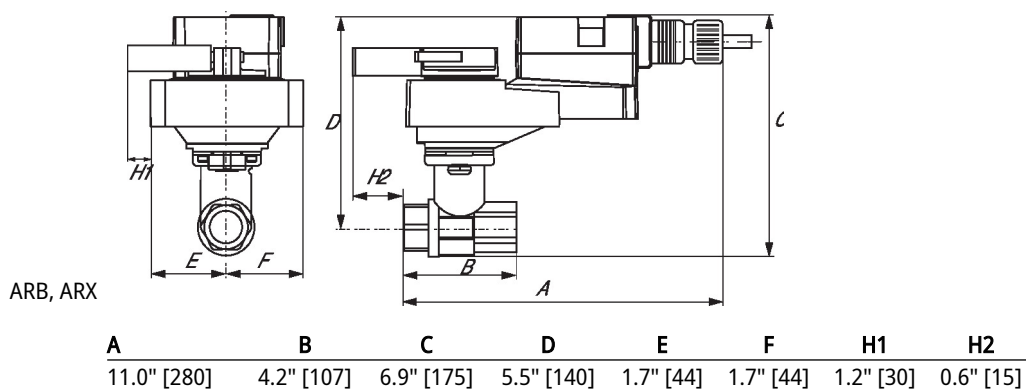
Flow/Mounting details

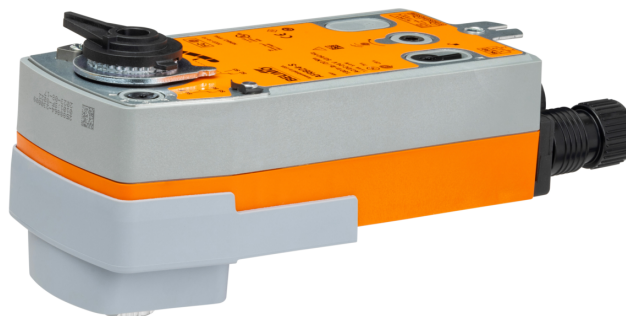

- Ⓐ Actuators with appliance cables are numbered.
- ⚠️ Provide overload protection and disconnect as required.
- ⚠️ Two built-in auxiliary switches (2x SPDT), for end position indication, interlock control, fan startup, etc.
- ⚠️ Actuators may be powered in parallel. Power consumption must be observed.
- ⚠️ Parallel wiring required for piggy-back applications.
- ⚠️ Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches. Mixed or combined operation of line voltage/safety extra low voltage is not allowed.
