## Electrical installation

- 1 Provide overload protection and disconnect as required.
- 3 Actuators may also be powered by DC 24 V.
- 5 Only connect common to negative (-) leg of control circuits.
- 7 A 500  $\Omega$  resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- 11 Actuators may be connected in parallel if not mechanically linked. Power consumption and input impedance must be observed.
- ◆ Meets cULus requirements without the need of an electrical ground connection.
