





Electrical installation

(A) Actuators with appliance cables are numbered.

(UP) Universal Power Supply (UP) models can be supplied with 24 VAC up to 240 VAC, or 24 VDC up to 125 VDC.

Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches. Mixed or combined operation of line voltage/safety extra low voltage is not allowed.

Meets cULus requirements without the need of an electrical ground connection.

A Provide overload protection and disconnect as required.

Actuators may also be powered by DC 24 V.

Actuators may be powered in parallel. Power consumption must be observed.
